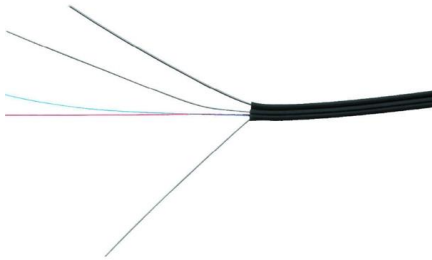

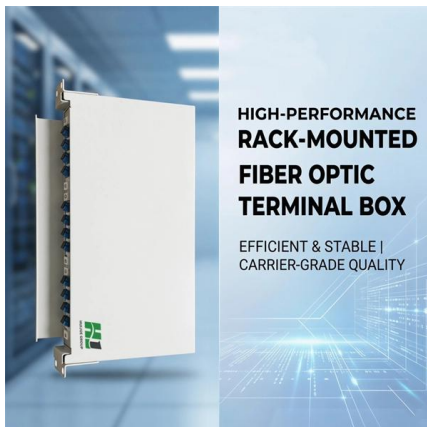
Bolivia Wireless Frequency Bands and Carriers

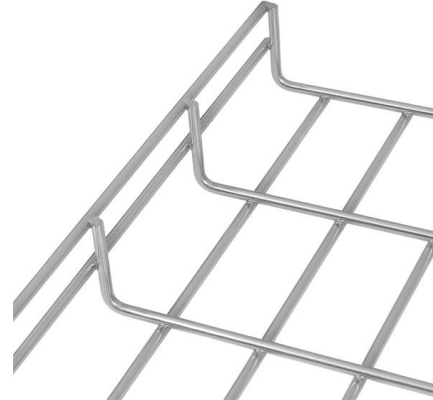
