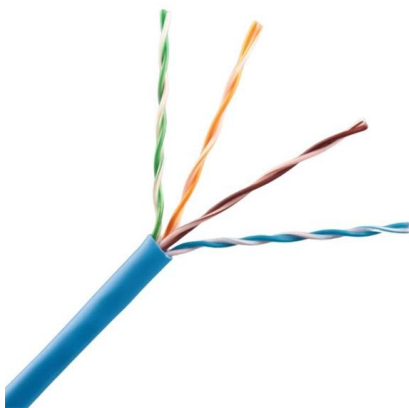

Remember that this equipment, even tho it's just a demarc block, it's federally regulated and if you piss them off by spreading this stuff, they might take it a step further with you legally.

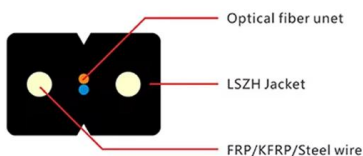
